



## **GENERAL RELEASE**

By signing below, I acknowledge and agree that:

1. I am voluntarily traveling on a Mediterranean Cruise provided by Royal Caribbean International/Navigator of the Seas (as part of the **Kenwood “Schmooze & Cruise III” 2012 Sales Incentive Trip**, sponsored and paid for by Kenwood U.S.A. Corporation -- hereafter, the “Trip”). 3. I also agree to indemnify and hold harmless the Releasees or anyone authorized by any of them from any and all losses, damages, costs, expenses, rights, claims, demands and actions which any other party may have against me or Kenwood U.S.A. Corporation arising out of or related to my participation in the Trip, including but not limited to personal illness or injury, death, disability, property damage, attorneys’ fees and expenses of litigation and settlement.

4. I understand that by signing this document I am fully releasing Kenwood U.S.A. Corporation and the other Releasees described in Paragraph 2, and I understand that California Civil Code section 1542 provides that:

A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of execution of the release, which if known by him must have materially affected his settlement with the debtor.
